## **Local Law Firm Rewards Safe Drivers with \$1,000**

*The Shapiro Safe Driving Giveaway raises awareness of distracted driving consequences*

Drivers interested in participating must enter at [ShapiroSafeDriving.com](http://ShapiroSafeDriving.com) where they will be directed to download the Motovate app, which monitors a driver’s phone usage while driving. For every mile driven without using their phone, participants will earn one entry in the giveaway. A winner will be drawn randomly, and it is possible for safe drivers to win more than once.
